2. Officiating Information

a. A reminder that all postseason contests are assigned by the UHSAA's Director of

3. Default Times

a. The default game times for home sites this Friday, Oct, 4 are 1:00 pm.

If you would like to change the game time, please work with the opposing school; game times can only be altered by mutual consent and if officials can be available. Please consult with the UHSAA office and the assigners prior to the assumption that you can move your game time.

4. Video & Streaming Rights

a. The UHSAA exercises postseason internet streaming & television rights. KSL Sports is the official streaming partners of the UHSAA. If a school or outlet wishes to stream or televise a state tournament game/event, permission must be granted from the UHSAA and/or the rights holder and is subject to a rights fee. KSLSports will allow all home site games to be streamed on your local network. Please send an email to jeffcluff@uhsaa.org as notification.

5. Communications

a. From here on out, all tournament-specific information will be communicated through

MaxMessenger in MaxPreps. Schools will be expected to read the information that is

communicated through that system.

6. Digital Ticketing

a. GoFan Ticketing is the Officials Ticketing Platform of the UHSAA and is required for all postseason events. If you choose to ticket your home site first-round game, please contact Jeff Cluff at the UHSAA office and he will assist you with setting up the digital ticketing platform for you home site event.

b. All schools ticketing for postseason play will use the GoFan digital ticketing platform. To purchase tickets at Snow Canyon and Kearns HS, follow the GoFan links on the UHSAA website. To avoid long lines, please advise your fans to purchase tickets through GoFan ahead of time.

c. Pass holders will receive wristbands through the gate at Snow Canyon and Kearns HS.

7. Coaches Credentials

a. Only certified coaches, wearing their UHSAA credential, will be allowed on the field to coach.

8. Pitch Count

a. We will continue to use the PitchKount software throughout the UHSAA postseason.

b. Please refer to the baseball section in the UHSAA Handbook specifics of the rule.

9. Run-Rule

a. The standard 10-run rule will be used after five innings

b. New this year the 15-run rule will be used after four innings of play
