Board of Trustees Meeting Summary January 23, 2025

- 1. Chairman Jerre Holmes called the meeting to order and welcomed everyone.
- 2. Mr. Rob Cuff, Executive Director, announced the Board of Trustees election results held at the USBA annual conference at Little America Hotel on January 10, 2025. Newly elected board members will officially begin service on July 1, 2025. Ms. Michelle Barber, Davis SD, was elected as the 5A School Board Representative and Mr. Mitchell Glazier, Kane SD, was elected as the 2A School Board Representative. An election for the Charter Schools Representative will be held on April 22, 2025, at 11:00 am at the UHSAA offices.
- 3. Mr. Cuff shared with the Committee a list of fall state champions and a fall financial report.
- 4. Mr. Jeff Cluff reviewed the calendar (<u>www.uhsaa.org</u>). Board of Trustees members were reminded to refer throughout the year to the UHSAA website for changes and updates to the calendar.
- 5. Mr. Chris Shipman discussed the importance of interested schools signing up for Unified Sports in soccer, basketball and track and field. Schools need to contact Chris for questions at the UHSAA office. The UHSAA has partnered with Special Olympics Utah for the past 10 years to hold events for these sports.
